ORDER

UPON MOTION in writing on behalf of the Plaintiff filed on July 22, 2010, pursuant to Rule 369(1) of the *Federal Courts Rules*, SOR/98-106, for:

1. An Order pursuant to Rule 383 of the *Federal Courts Rules* designating this action as a specially managed proceeding;

2. A case management conference to discuss scheduling matters for this motion and to schedule October 4, 2010, or the first available date thereafter, as the hearing date for the parties' summary judgment motions;
3. An Order granting the Plaintiff leave to serve and file the Certificate of Registration of Copyright dated June 23, 2010 for his unpublished literary works, entitled Farmans; and
4. Such further or other relief as counsel may advise and this Honourable Court may permit.

AND UPON reading the Motion Record of the Plaintiff, a letter dated July 29, 2010 from the Defendants, a letter dated August 4, 2010 from counsel for the Plaintiff, the Direction of Madam Justice Heneghan, there being no responding submissions from the Defendants; and upon being satisfied that this is a case which should be specially managed and that the Plaintiff be granted leave to file the supplementary evidence;

THIS COURT ORDERS that:

1. This action shall proceed as a specially managed proceeding and be referred to the Office of the Chief Justice for the appointment of a Case Management Judge.
2. The Plaintiff is granted leave to serve and file the Certificate of Registration of Copyright dated June 23, 2010 for his unpublished literary works, entitled Farmans.

- 3. The parties shall provide to the Court within 15 days of the date of this Order mutually convenient dates for a case management conference to be held with the Case Management Judge.
